Summary

The 'Y' type network in Cheshire requires the LV network to be manually managed/switched during 11kV fault isolation and restoration. The LV network has to be disconnected in order that there will be no backfeeds onto the fault while isolating. It is then reconnected after the 11kV restoration. Care has to be taken so that any stage in the process does not overload the LV network. This may involve closing 11kV breakers simultaneously at each end of the fault. Lynx is an electromechanical device that will automatically during the fault conditions.
