## Summary

Technical and practical evaluation of a surveying system, previously used in the United States, to detect the presence of voltages on metallic street furniture and DNO apparatus installed in the public highway.

The aim of this project is to prevent members of the public being exposed to electrical voltages that have the potential to cause them harm.

An evaluation of the system's potential to provide an innovative and cost effective method for determining the condition of buried underground cable and associated plant, including the identification of any defects present, will also be undertaken.
