This project, which is partly funded by the Technology Strategy Board (TSB), builds on learning obtained in the LCNF Tier 2 funded 'Low Carbon London' project in which Active Network Management and Demand Response activities are being assessed to understand their suitability as well as the opportunity available for DNOs.

The learning obtained within the Low Carbon London project has indicated that the existing commercial opportunities for Combined Heat and Power (CHP) systems, particularly small scale units, limits their ability to provide ancillary services.
