The Scottish and Southern Energy Power Distribution DECC funding award requires delivery of the 1MWe battery by end March 2011, as a result procurement is well underway, additional functionality of this battery will feature in our Tier 2 bid. This Tier 1 bid secures the initial learning from the installation and operation of the battery and integration with local Demand Side Response to remove station peaks providing additional Demand capacity (in a similar way to managing a network load constraint).

Scottish and Southern Energy Power Distribution's Tier 2 element subsequently deals with the optimisation of potentially simultaneous

modes of operation including:

- Renewable Generation constraint avoidance
- Power station operation optimisation (to reduce fuel consumption)
